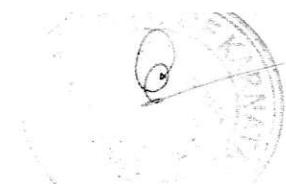

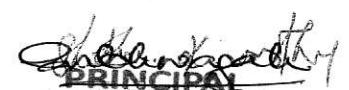

- 5) Those are willing to become the members must be abide the rules and regulations of the associations

6) Losing the membership :-

- 1) When the members do not pay the monthly membership fee continuously for three months
- 2) The membership will be automatically ended in case of the death and mental retardness of a member
- 3) Member /s lose their membership when they are involved in criminal cases
- 4) The committee is empowered to remove the members who work against the institution .

7) Mode of working ;-

The different activities of association are to be conducted as follows according to the rule

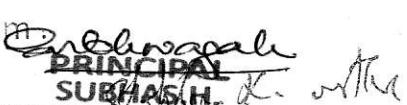
- 1) General body meeting (sarva sadharana sabhe)
- 2) Working committee meeting (karya kari samithi sabne)

8) Annual generalbody meeting ;-

- 1) Annual general body meeting means a meeting of all category members of the association
- 2) Annual general body meeting must be held every year without fail ,in case to be postponed ,it can be postponed for three months but no chance for further postponement .
- 3) For the annual general body meeting measures must be taken according to section of 1960's KSR act and a notice with agenda must sent to the members at least 15 days earlier to the meeting
- 4) If the president wants or one third of the members file their objection in writing ,a special general body meeting can be held .
- 6) The notice for special general body meeting must be sent at least one day earlier to
 - a. the members .[a/c to the section 11(3)]
- 7) One third majority of the members will be the corum for annual or special general body meeting
- 8) If there is no corum for the meeting ,it can be postponed for half an hour on the same day and can be held after that even without corum

) Those who contest in the election must have one year membership of the association .

10) To cast the vote in the election one should have at least six months membership of a. the association.

11) Election can be held either by secret voting or by rising the hands.

12) The audited accounts of the association are to be accepted after verification .

13) The budget of the association is verified and approved and the annual report is also approved

14) The forth coming appeals are verified and proper decisions are taken on them

15) The rules and regulations of the association are amended a/c to its necessities .

9] Working committee :-

- Consists of 9 members elected in annual general body meeting . The members so elected further choose president secretary and treasurer among them and the rest will be the directors of the committee

1) The working committee must arrange bi monthly meeting to verify the programmes .

2) The meeting notice must be sent one week before to the committee meeting .

3) The members who absent three consecutive will loose their membership .

4) For such vacant post can choose another member as a nominated member .

5) Such nominated member will continue as working committee member till further election .

6) The working committee is empowered to recruit the employes /staff required to work in the association .

7) The working committee is empowered to implement all the programmes of the association .

8) The accounts of the association must be audited every year and approved by general body meeting .

10) Duties of the office bearers of the working committee:-

1) President

1) The president is going to preside all the meetings of the members of working committee and general body meetings.

2) The president has to look after and supervise all the aspects of the working committee.

3) The president has to advise the secretary in letter correspondence and look after the same .

4) Along with the secretary through joint account the president has to carry out bank

5) The president has to guide the secretary and take steps to get the help / co-operations by government /NGO,s /Publics .

2) Vice president :-

1)In the absence of president, the vice president has to look after all his activities .

3) Secretary:-

1) The secretary must be the honorable member of the association and look after all the day-to-day activities on his own in favor of the association.

2) He is responsible to carry out all letter correspondences under the guidance of president .

3) Sending notices to all the meetings and to enlist the agenda etc .

4) He has to sanction the expenses approved by the working committee for all the programmes.

5) He is empowered to buy or to get legally the land , building etc ,required for the development of the association .

6) Has to represent the association in all aspects as per the committee decisions .

7) The secretary has responsibility to implement all the decisions.

8) He is empowered to take legal action on the staff /employees after giving sufficient time.

9) Has responsibility for bank transactions jointly with the president .

10) He can keep Rs 100 from association money to spend at special times.

11) Has to help the auditor by Providing proper accounts and explanations in auditing .

12) Secretary will be the back bone and lead the institution in an excellent manner by having good public contact .

4) Joint secretary :-

In the absence of secretary the joint secretary has to look after the accounts and has to work for well being of the association along with the secretary.

5) Treasurer :-

1) Proper maintenance of the accounts of membership fee , and to preserve the relevant records with the cooperations of the secretary.

2) Preparing budget accounts books of the society is treasurers prime duty .Receipt book , bank pass book ,and cheque book or in his control .

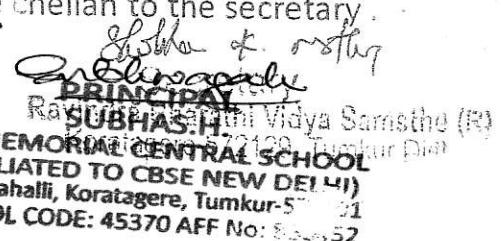
3) Giving complete cooperation to the secretary in yearly auditing the accounts and reporting the same in the general body meeting .

11) Resignation :-

Those who want resign to the membership have to give their application to the president ,but decision is left to the working committee

12) Association fund (financial transactions)

18) General:-

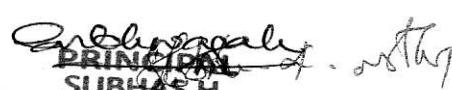
